## **PENALTY**

- A **5%** penalty will be added to the unpaid taxes the first 10 days after the due date.
- A **10%** penalty will be added to unpaid taxes 10 days after the due date

## **INTEREST**

An additional interest charge, set by the tax commissioner, will be added twice a year on unpaid delinquent taxes. These dates are the first day of the month following the second half due date and December 1.

## **FORECLOSURE**

If taxes are not paid within sixty (60) days from the date they are certified delinquent, the property is subject to foreclosure for tax delinquency under chapter 5721 of the revised code.

## **NOTICE**

If the taxes charged against this parcel have been reduced by the owner occupancy credit for residences occupied by the owner but the property is not a residence occupied by the owner, the owner must notify the County Auditor's office no later than March 31 of the year following the year for which the taxes are due. Failure to do so may result in the owner being convicted of a fourth degree misdemeanor, which is punishable by imprisonment up to 30 days, a fine up to \$250 or both, and in the owner having to repay the amount by which the taxes erroneously or illegally reduced, plus any interest that may apply.

If the taxes charged against this parcel have not been reduced by the owner occupancy credit and the parcel includes a residence occupied by the owner, the parcel may qualify for the reduction. To obtain an application for the reduction or further information, the owner may contact the County Auditor's office at 428 W. Liberty St. Phone 330-287-5430.

## **MILITARY EXTENSION**

The County Treasurer shall include a notice of, and information about, the extension provided in R.C. 323.122 for members of the National Guard or reserve components of the U.S. Armed Forces that are called to active duty. This notice may be in the form, and contain the content, prescribed by the Treasurer without the approval of the Tax commissioner. Alternatively, this notice requirement may be satisfied by providing notice and information to a newspaper in general circulation in the county when the tax bills are mailed. This notice requirement applies to all tax bills mailed under R.C. 323.133.
